ACCEPTING SILENT AUCTION BIDS FOR 2019 THUNDER
OVER LOUISVILLE BOAT DOCK USE PERMITS**

The City of Jeffersonville is accepting silent bids for boat dock slip use during Thunder Over Louisville 2019. A dock will be assigned to a successful bidder based on the amount of the bid, size of vessel, and date the bid is received in the Parks Department office. The City of Jeffersonville reserves the right to reject any and all bids.

Bidders must agree to the Terms of use on page 2. After notification of winning bid, payments will be due the 1st week of April. Submit page 3 bid information sheet which includes the following:

- Your name, address, telephone number and email address.
- The size of your vessel-both overall length and width.
- The name of your vessel and registration number (if applicable).
- Dock requested: #3-15 are available for bid. See diagram on page 3.
- The dollar amount you bid for use of a dock slip during Thunder 2019, and
- The signed Terms of Use page 2

Terms of Use

Terms of use for boat dock slip auction winners during Thunder Over Louisville on April 13 & 14, 2019:

- The permit issued by the City of Jeffersonville must be displayed on a bow-facing window, in view, for inspection at all times.
- Vessel must be in the marina, in the proper slip before 2:00 pm on Saturday, April 13, 2019.
- Once moored in the marina, no vessel will be allowed to leave until the river has been opened to traffic (estimated to be 11:00 p.m.).
- As a security measure, each boat may be boarded and inspected once docked in the marina.
- The first two docks number 1 and 2 closest to the River Stage are reserved for First Responder Agencies.
- Indicate your dock number preference, your selection will be considered on a first come first serve basis but is NOT guaranteed. Dock numbers available are 3 through 15 traveling east or upstream. See diagram on page 3.
- No lawn chairs or other furniture may be placed on docks.
- Occupants of vessel may stay on the vessel in the marina until 3:00 pm Sunday, April 14, 2019.
- This permit does not authorize any banners or advertising in the marina.
- No commercial use or sales of any type on vessels in the marina at any time.
- The City of Jeffersonville reserves the right to distribute the power that is available at the docks and determine final dock slip assignment.
- Neither water nor electrical power is guaranteed at the docks.
- Provide a Certificate of Insurance on your vessel.
- Dock bids will be refunded if the river levels are not permissible to host the event. That decision will be made the Monday before the event.
- **VIOLATIONS OF THESE CONDITIONS, OR OF ANY LAW, ARE CAUSE FOR PERMIT REVOCATION.**
